existing under the laws of the State of Oregon, and each of its directors, officers, and agents. The Mentor desires to provide volunteer services to STM and engage in activities related to mentoring student sewers.

Mentor understands that the scope of Mentor’s relationship is limited to a volunteer position and that no compensation is expected in return for services provided; that STM will not provide any benefits traditionally associated with employment to Mentor and that Mentor is responsible for his/her own insurance coverage in the event of personal injury or illness resulting from Mentor’s services to STM.

1. **Waiver and Release:** I, the volunteer Mentor, release and forever discharge and hold harmless SEW TEACH ME™ its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the services I provide to STM. I understand and acknowledge that this Release discharges STM from any liability or claim that I may have against STM with respect to bodily injury, personal injury, illness, death or property damage that may result from the services I provide to STM or occurring while I am providing volunteer services.
2. **Insurance:** I understand that STM does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance of any nature in the event of my injury, illness, death, or damage to my property. I expressly waive any such claim for compensation or liability on the part of STM beyond what may be offered freely by STM in the event of such injury or medical expenses incurred by me.
3. **Medical Treatment:** I hereby Release and forever discharge STM from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with STM.
4. **Assumption of Risk:** I understand that the services I provide to STM may include activities that may be hazardous to me, including but not limited to, use of scissors, rotary cutters, irons, and electric sewing machines. As a volunteer Mentor, I expressly assume the risk of injury or harm from these activities and release STM from all liability for injury, illness, death or property damage resulting from the services I provide as a volunteer or occurring while I am providing volunteer services.
5. **Photographic Release:** I grant and convey to SEW TEACH ME™ all right, title and interests in all photographs, images, video or audio recordings of me or my likeness or voice made by STM in connection with my providing volunteer services to STM.
6. **Other:** As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Oregon, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Oregon. I agree that in the event any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
